

Directions to the Northumberland County Conservation District Office

From Lewisburg and points west –

Follow US route 15 South towards Shamokin Dam. Shortly after you pass the K-Mart on your right, there will be an exit for Sunbury on route 61. Take the exit, and go across the bridge. Stay in the left lane on the bridge, it will put you on Front Street in Sunbury. Go to the first traffic light and turn right onto Market St. Follow Market (SR 61) all the way through town. Shortly after leaving town, you will go through an underpass. Approximately 1/2 mile later, turn right onto SR 890. Follow 890 for about 1.1 miles. About halfway up the first hill, turn left onto Plum Creek Road. Travel on Plum Creek Road about 0.7 miles, and the office is on the left. We are the only office building on Plum Creek Road.

From Bloomsburg and points east –

Follow US route 11 south through Danville, and on to Northumberland. In Northumberland, 11 turns left onto King Street (one way), get into the center lane. Go straight through the traffic light, and across both bridges. At the end of the second bridge, take the right hand lane, and merge onto Front Street in Sunbury. Stay on Front Street until the second traffic light, which is Market Street. Turn left onto Market Street. Follow Market (SR 61) the entire way through town. Shortly after leaving town, you will go through an underpass. Approximately 1/2 mile later, turn right onto SR 890. Follow 890 for about 1.1 miles. About halfway up the first hill, turn left onto Plum Creek Road. Travel on Plum Creek Road about 0.7 miles, and the office is on the left. We are the only office building on Plum Creek Road.

From Shamokin area –

Head towards Sunbury on Route 61. Shortly before entering Sunbury, SR 890 will be on your left. Follow 890 for about 1.1 miles. About halfway up the first hill, turn left onto Plum Creek Road. Travel on Plum Creek Road about 0.7 miles, and the office is on the left. We are the only office building on Plum Creek Road.

From Harrisburg area –

Follow US routes 11 & 15 North towards Shamokin Dam. Shortly after you pass the Hoss's on your right, there will be an exit for Sunbury on route 61. Take the exit, and go across the bridge. Stay in the left lane on the bridge, it will put you on Front Street in Sunbury. Go to the first traffic light and turn right. Follow Market Street (SR 61) all the way through town. Shortly after leaving town, you will go through an underpass. Approximately 1/2 mile later, turn right onto SR 890. Follow 890 for about 1.1 miles. About halfway up the first hill, turn left onto Plum Creek Road. Travel on Plum Creek Road about 0.7 miles, and the office is on the left. We are the only office building on Plum Creek Road.
